NO PURCHASE OR DONATION NECESSARY

No Purchase or Payment of Any Kind is Necessary to Enter or Win the Sweepstakes

The Sweepstakes is open to individual legal residents of the 50 United States and the District of Columbia, excluding residents of Rhode Island. The Sweepstakes is open to U.S. residents who are at least 18 years of age or older as of the date of participation. Valid consent of parent or legal guardian required for entrants under age 18 (19 in Alabama and Nebraska, and 21 in Mississippi). The Sweepstakes is not open to employees or to immediate family and household members of employees of The Ronald Reagan Presidential Foundation ("Sponsor"). Void where prohibited.

The Sweepstakes will begin at 6:00 AM (Pacific Time) on Monday, March 1 and will continue through 11:59:59 p.m. (PT) on Friday, March 12. To be eligible for the drawing, completed entries in legible form must be received by Sponsor by no later than 11:59:59 p.m. (PT) on Friday, March 12.

Winner will be selected by random drawing from all eligible entries on March 15, 2010 and will be notified by e-mail or telephone on or about March 16., 2010. Winner need not be present to win.

There will be one (1) prize consisting of a free trip to Los Angeles for the Centennial Celebration on the weekend of February 5-6, 2011. The trip includes two roundtrip coach airline tickets, one room for two nights at a local hotel designated by Sponsor, VIP tour of the Ronald Reagan Presidential Library, two tickets to the Centennial Concert for America at the Hollywood Bowl, and \$500 cash. Prize does not include ground transfers, ground transportation, meals, taxes, or resort fees. The total average retail value of the prize is \$2,000 to \$4,500. If winner cannot or will not accept the prize as stated, the winner will forfeit the prize. An alternate winner will then be drawn.
